NOTIFICATION

WHEREAS, the Sriniketan Santiniketan Development Authority constituted as Development Authority under the West Bengal Town and Country (Planning and Development) Act, 1979 (hereinafter referred to as the said Development Authority) with effect from the 14th day of December, 1989, under the Notification No. 3961-T&CP/1S-25/87, dated the 14th December, 1989 of Government of West Bengal, Development and Planning (T&CP) Department in respect of the Planning Area declared as such under Notification No. 3960-T&CP/1S-25/87, dated 14th December, 1989 read with Notification No. 4069-T&CP/1S-25/87 dated the 22nd December, 1989.

AND WHEREAS in pursuance of the provisions under sub-section (1) of section 36 of the West Bengal Town and Country (Planning and Development) Act, 1979 (West Bengal Act XIII of 1979) (hereinafter referred to as the said Act), the said Development Authority duly published the Land Use and Development Control Plan for its Planning Area in the Official Gazette and local newspapers.

AND WHEREAS in pursuance of the provisions under section 40 of the said Act, the said Development Authority duly prepared a revision of the present Land Use and Development Control Plan for its Planning Area.

AND WHEREAS in pursuance of the provisions under sub-section (1) of section 36 of the said Act, the said Development Authority further published the revised Land Use and Development Control Plan in the Official Gazette and local newspapers.

AND WHEREAS in pursuance of the provisions under sub-section (3) and (6) of section 36 of the said Act, the said Development Authority considered the objections, made some modifications in the Land Use and Development Control Plan and submitted the said Plan with modifications together with its report to the State Government.

AND WHEREAS in pursuance of the provisions of section 37 of the said Act, State Government accorded its approval with modifications.

AND WHEREAS in pursuance of the provisions of section 38 of the said Act, the said Development Authority hereby publishes this public notice of the approval of the revised Land Use and Development Control Plan, copy of which may be inspected at the Office of the Executive Officer, Sriniketan Santiniketan Development Authority, 'Kshanika', near Bolpur Bus Stand, P.O.- Bolpur, District- Birbhum between 11 A.M. and 3 P.M. on any working day.
